\*Call to Men Training by Tony Porter was an excellent. Tony Porter is a dynamic speaker and it is recommended that all take advantage and attend a future training if possible.

\*Coaching Boys to Men kicked off in Buffalo. It was held at a Buffalo Public School and several dignitaries, the community at large and 20 young men attended the event.

### **Peggy McIntosh Presentation**
